A MESSAGE FOR THE PARTICIPANT:

The global economic landscape has changed significantly over the first quarter of the 21st century. The shift of the economic pole towards the countries of the Global South and East, primarily BRICS member states, is imminent; a faster pace of development is expected in most of the countries in the medium term. While at the beginning of the century BRICS economies accounted for only one fifth of the world economy, today the total economic potential of BRICS in terms of goods production, resource extraction and population has the largest share in the world.

The new wave of global economic growth is determined by such factors as technology, education, resources, trade, logistics, and financial infrastructure. Much has already been done, but additional support and investment are needed to fulfil the natural economic potential and advantages in the most efficient way possible.

Investment is synonymous with development. Investments need to be directed towards revealing human potential through education, skills development and addressing demographic imbalances, emerging technology that improves the quality of life, creating a comfortable and favorable living environment, and strengthening informational, institutional and physical communication between people and countries.

All of this demonstrates that New Platform for Global Growth is being formed, based on BRICS founding principles of consensus, fairness and openness for the sake of human well-being. It is up to an individual to determine their own future, giving key impulses to development through their choice.

INVESTMENTS IN ENVIRONMENT:

ENVIRONMENTAL COMFORT has a significant impact on both human wellbeing and overall economic productivity. Which investment initiatives and solutions under New Platform for Global Growth will create a more comfortable, sustainable and safe living environment?

- Transport accessibility for everyone.
- Creating comfortable environment subject to climate change.
- The potential of the circular economy.
- A path to creation: corporate social responsibility as a global norm.

- Barrier-free and inclusive environment luxury or necessity.
- Conscious consumption as the basis for conscious supply.
- Opportunities for the development of sustainable tourism to enhance the quality of the urban environment

INVESTMENTS IN COMMUNICATION:

The global economy is becoming increasingly interconnected through the development of international trade, transportation, digital infrastructure, and the growth of information flows. What strategic investments in communication will contribute to accelerating economic growth, enhancing international interactions, and unlocking emerging opportunities in New Platform for Global Growth?

Topics for discussion:

- Future of trade.
- Reducing barriers to services trade the opportunity of the century?
- Approaches to infrastructure development in the 21st century.
- New logistics routes in the Global South and East.
- How to build an intercultural dialogue?
- Global challenges and responses of insurance industry.
- Improving financial flows.
- Digital currencies as a tool to increase international financial network.
- Data mobility as part of global communication.
- E-commerce and logistics platforms.

Essays should be submitted to the organizer of the Open Dialogue "The Future of the World: New Platform for Global Growth" via e-mail, with an indication of the topic of the essay and a reference to the thematic block.

The shortlisted essays provide the author with the opportunity to participate in the Open Dialogue "The Future of the World: New Platform for Global Growth", which will be held in Moscow on **April 28-30, 2025**, with participation of political, economic and business leaders from the countries involved in the Dialogue.

The essay competition winners are also invited to participate in leading international economic forums, including the St. Petersburg International Economic Forum (Russia, St. Petersburg, June 18-21, 2025).

Following the results of the competition, the organizer of the Open Dialogue publishes a collection of essays, which is distributed among the participants of the Dialogue, as well as among the delegates of the St. Petersburg International Economic Forum.

ESSAY REQUIREMENTS

Working language: Determined by the author of the essay

The volume of the presented material: Up to 5 printed A4 sheet (report time up to 10 minutes)

Structure:

- 1. The title corresponding to the subject of the essay
- 2. Specifying a thematic vector
- 3. Preamble: prerequisites for writing an essay, relevance of the topic (in terms of challenge/opportunity)
- 4. Revealing the core of the hypothesis, supported by analytical insights, statistical data and predictive models.
- 5. Emphasis on economic and social effects
- 6. General conclusions, expected results

Ethical requirements:

- 1. The observance of copyright laws, the proper attribution of authorship in case of quotation and reference
- 2. Avoiding plagiarism
- 3. Avoiding direct advertising
- 4. Avoiding unsubstantiated criticisms of the leaders of countries, corporations, and participants in dialogue
- 5. Refraining from making disparaging remarks based on nationality, religion, physical attributes, or any other principle
- 6. Preventing calls for action that are in contravention of criminal law, human rights, the constitutional law of states, etc.

Requirements for the essay format

Document in text editors with *.doc, *.txt resolution The submitted materials should not be secured with passwords or any other authentication measures

EVALUATION OF SUBMITTED ESSAYS:

In order to enhance the prospects of successful participation in the contest, all submissions are rigorously assessed based on a set of criteria. The essay receives a maximum score of 70 upon evaluation. This score is factored into the overall ranking of the contestants.
